DEED OF DEDICATION

KNOW ALL PERSONS BY THESE PRESENTS: THAT [Carlton Landing Association, Inc.], an Oklahoma Corporation, Grantor in consideration of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, including, but not limited to, acceptance of this dedication for public road purposes, does hereby grant, bargain, sell, convey and dedicate unto the Town of Carlton Landing, Pittsburg County, Oklahoma, for the purpose of establishing and maintaining a public road and facilities necessary or incidental thereto, and for the purpose of affording the right to enter upon said premises and strip of land for the purpose of surveying, excavating for, construction, operating, repairing and maintaining such public road together with all necessary and convenient appurtenances thereto, the following described parcel of land:
