\_\_\_\_\_ Fireworks may not be discharged on any public street, lane, alley, sidewalk, public easement, public property, or property generally used and accessible to the general public

\_\_\_\_\_ Permit Holder agrees to not discharge or allow to be discharged during dates and times outside of the authorized dates and times:

1. Residential Areas

- a. Seventy-two (72) hours before and seventy-two (72) hours after July 4 each year between the hours of Noon (12:00) p.m. and ten thirty o'clock (10:30) p.m.
- b. July 4 of each year between the hours of Ten o'clock (10:00) a.m. and Twelve o'clock (12:00) midnight, and
- c. December 31st of each year between the hours of Nine o'clock (9:00) p.m. and Twelve Thirty o'clock (12:30) a.m. on January 1st of the New Year.

2. Overlook and Town Green Areas

- a. From the Friday prior to July 4 through the Sunday following July 4 between the hours of Noon (12:00) p.m. and ten thirty o'clock (10:30) p.m., except on July 4
- b. July 4 of each year between the hours of Ten o'clock (10:00) a.m. and Twelve o'clock (12:00) midnight, and
- c. December 31st of each year between the hours of Nine o'clock (9:00) p.m. and Twelve Thirty o'clock (12:30) a.m. on January 1st of the New Year.

\_\_\_\_\_ Permit agrees to pick-up and clean area after fireworks have been discharged, especially if using the Overlook or Town Green areas.

Failure to follow the regulations agreed to and provided within the Fireworks Ordinance can result in a fine of up to \$200.00.
