- Stephens Road: someone added some rock to try and block it. We don't know the exact date the road will be open to traffic.
- Security around the marina center each business owner has some responsibility and HOA has responsibility for common areas. On the Marina Dock within the slips the Carlton Landing Association and owners responsible for security.
